DEPARTMENT POLICY

All applications for permits and approvals shall be accompanied by the fee established in this Lake County Board policy below. All applicants, including Home Owners Associations, religious organizations, units of government, and not-for-profit organizations, shall pay the fee as part of the application process. Only those specifically exempted by state law are exempt from the fee schedule.

BUILDING PERMIT FEE SCHEDULE (Residential)

Residential volume shall be computed on the exterior dimensions of the building, and shall include all space above the lowest level of the foundation wall and below the ceiling or bottom cord of roof truss of the uppermost floor. Unit of volume of cost: Figure a major fraction as a full unit.
